

List of Municipalities That Restrict Smoking in Service Areas

According to the U.S. Surgeon General, secondhand smoke exposure is harmful at any level. Therefore, many cities and counties in California have taken steps to protect their residents from this danger by passing ordinances that restrict smoking in outdoor service areas where people congregate, such as ATM lines, public transit stops, taxi stands and ticket lines.

There are 148 municipalities in California that have restricted smoking in service areas. The table below lists all of these cities and counties and divides the policies into two categories:

1. Municipalities that prohibit smoking at all service areas

There are 117 municipalities with this type of policy. This is the strongest type of restriction because smoking is not permitted in any type of service area, ensuring that residents will not be exposed to secondhand smoke while waiting for buses, movies or any other service.

2. Municipalities that prohibit smoking at some types of service areas but not all service areas

There are 31 municipalities with this type of policy. For example, some cities only prohibit smoking at bus stops but not other service areas. Such policies help to protect people from secondhand smoke, but mean that people can continue to be exposed to secondhand smoke in other types of service areas where smoking is not restricted.
